Please Note **Well. No refunds will be done to any payment made to the school if the child is being withdrawn by the parent within any given time of the school calendar.**

- Per annum:** School fee for the year can be paid in full before 28 February. A discount between 5 and 10% is given for this option. Depending on how many learners, a parent enrolls from the same family.
- Installments:** school fees can be paid per term or in 10 installments from January to October on the third of each month. **No learner will be allowed in class without a proof of payment.**
- Debit order scheme:**
- Parents are expected to sign a debit order for the payment of fees and extras when their children join the school unless if a payment is fully made per term. A debit order form is only obtained at the school.
- If a parent does not approach us to discuss the payment option that she/he will like to use in a particular year, we will assume that she/he is using the same option as used the previous year.
- Direct deposits are possible for parents who have arranged to make payments outside of the electronic debit order scheme. Should you make use of this option, it is imperative that a copy of your deposit slip, with your child's name(s), grade and details of payment be emailed through to accouts@stmarksschool.co.za
- Development fund:**
A development fund levy of R1000 per family that ensures the secondary development of the school facilities will be requested by the school. This will be a compulsory levy fee to be paid by all registered learners at the school.
- Book fee/Tablet**
Parents are at liberty to purchase learning material for their children in consultation with subject educators. Alternatively, a book fee of R4 500 will be required for the purchase of all learning material including study guides at less price through the school. We encourage parents to consider buying tablets which are obtainable at school as per order
- Notice of withdrawal**
On withdrawal of a child, parents are expected to give the school a full Term notice in writing. This is to be addressed to the head. Where this is not given, parents will be liable for the fees of the whole year. **Boarding** – children who are admitted to the boarding house will make commitments for a calendar year. Please take note that there is no rebate on fees for this option as there is very little possibility of filling the vacated space at the late stage.
- Council policy on Fees.**
It is the policy of St Mark's School that a pupil whose fees have not been paid at the stipulated time, will be asked to leave the school forthwith. The parent will be advised to take his/her child to home schooling. This will be communicated to parents telephonically as well as by means of letters. The child may be re-instated upon full payment of all outstanding amounts and may ordered pay fees through a debit order.
- Policy on Selective Admission for Sport Codes.**
Parents who their children are admitted to the school due to their sporting talents, should submit proof of income to determine the amount they should pay if they need Bursaries. The amount to be paid should be to cater for meals, transport to and from games, water and lights. Affording parents will have to pay full fees.
- School Examination Policy (SEP)**
Learners will not be allowed to sit for Trial Exams or Final Examinations if their portfolio work is incomplete. Learners will only be allowed to write the learning area which has all assessment tasks completely done by September of each year to the required standards. This policy includes Grade 12 candidates who may not have completed or submitted their tasks for SBA purposes. The final exam entry mark will be 60% per learning area and should be achieved during trial exam.
- Promoted Learners**
Learners who got promoted to Grade 12 class due to Departmental policy, will be expected to do FIVE learning areas unless otherwise they achieve satisfactory during mid-year results.
